**ORDINANCE NO. 1000**

**AN ORDINANCE ESTABLISHING THE APPOINTMENT OF A NUISANCE ABATEMENT OFFICER AS A MEMBER DESIGNATED OF THE PUBLIC WORKS DEPARTMENT.**

**THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. MARY, MISSOURI, AS FOLLOWS:**

**SECTION 1. ESTABLISHING THE POSITION OF A NUISANCE ABATEMENT OFFICER.**

Mayor and the Board of Aldermen upon the majority approval and passage establish the appointed position of a Nuisance officer as a member of public works Department as a hybrid trained position.

**SECTION 2. DUTIES**

The City of St. Mary's nuisance officer whose duties shall include enforcing all provisions of the City of St. Mary Ordinances relating to nuisance, disabled and abandoned automobiles, animal regulations and / dangerous/substandard buildings during times of normal public works task are unable to be completed during down time.

The nuisance officer shall be under the direct supervision of the Mayor and the Board of Aldermen and file all nuisance reports to the police department for issuance of warnings and/ or citations of violations by a member of the police department and will act under official capacities as allowed by state law.

The officer may also be assigned such duties as the public works/ Water operator at the discretion of the Aldermen or Mayor that may require within or outside the department, such as enforcing condemnation of substandard buildings and assisting the Fire Chief and Police Chief and act in the absence as City of St. Mary Building inspector.

**SECTION 3. Repeal of Conflicting Ordinances.**

All ordinances and parts of ordinances in conflict herewith are hereby repealed.

**SECTION 4. Effective Upon Passage.**

This ordinance shall be in full force and effect from and after its passage and approval by the majority of the City of St. Mary Board of Aldermen

**SECTION 5. Incorporation into Municipal Code**

The City Clerk shall incorporate the terms of this Ordinance into the official City of St. Mary City Code with all due dispatch.
