

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A LEASE AGREEMENT WITH THE MISSOURI DEPARTMENT OF CONSERVATION TO LEASE CITY OWNED LAND TO BE DEVELOPED FOR THE USE OF THE GENERAL PUBLIC; AUTHORIZING THE MAYOR TO SIGN ALL NECESSARY DOCUMENTS AND DESIGNATING WHEN THIS ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. MARY, MISSOURI, AS FOLLOWS:

**SECTION 1.** The mayor is hereby authorized on behalf of the City of St. Mary, Missouri, to enter into an agreement with the Missouri Department of Conservation to lease city owned land to be developed for the use of the General Public. This lease is an amendment to the Lease Agreement between the City of St. Mary and the Missouri Department of Conservation dated September 12, 1985. With this amendment the City of St. Mary is leasing Lots 3 thru 17 in City Block 17 for the purpose of constructing an entrance road and overflow parking area for the St. Mary Access (Boat Ramp).

**SECTION 2.** The Department of Conservation agrees to construct an entrance road and overflow parking area on this addition.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and approval.


The Department agrees to construct an entrance road and overflow parking area on this addition.


