

**AN ORDINANCE ESTABLISHING A TRUCK ROUTE AND WEIGHT LIMITS ON CITY STREETS AND DESIGNATING WHEN THIS ORDINANCE SHALL TAKE EFFECT.**

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. MARY, MISSOURI, AS FOLLOWS:**

**SECTION 1. TRUCK:** Any vehicle, machine, tractor, trailer or semi-trailer, or any combination thereof, propelled or drawn by mechanical power and designated or used in the transportation of property upon the highways.

**SECTION 2.** Except for the limited purpose of effecting occasional pick-up and delivery service, no vehicle licensed to haul in excess of eighteen thousand pounds (18,000) shall be moved, operated or parked on any street, thoroughfare or alley in the City of St. Mary, MO. except for US. Hwy 61 and Mulberry Street.

**SECTION 3.** Signs giving notice of the foregoing ordinance shall be erected and maintained by the city at all points of entrance for vehicular traffic into the city.

**SECTION 4.** If any vehicle is found upon a street in violation of any provision of this Chapter relating to the stopping, standing or parking and the identity of the operator cannot be determined, the owner of person in whose name such vehicle is registered, shall be held prima facie responsible for such violation.

**SECTION 5.** Any person violating any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be punished by a fine not exceeding \$500.00 and cost or by no more than ninety (90) days in jail and costs.

**SECTION 6.** All ordinances or parts of ordinances in conflict are hereby repealed.

**SECTION 7.** This ordinance shall be in full force and effect from and after its passage and approval.
