ORDINANCE NO. 767

AN ORDINANCE ESTABLISHING TRAFFIC FINES FOR THE ST. MARY MUNICIPAL COURT AND STATING WHEN THIS ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. MARY, MISSOURI, AS FOLLOWS:

SECTION 1. The Board of Aldermen of the City of St. Mary, Missouri do hereby establish the attached Traffic fines for the St. Mary Municipal Court.

SECTION 2. This ordinance shall be in full force and effect on April 28, 2004.

SECTION 3. All ordinance or parts of ordinance in conflict are hereby repealed.
