ORDINANCE NO. 770

**AN ORDINANCE RE-NAMING A SECTION OF FOURTH STREET TO IMMACULATE CONCEPTION DRIVE; CHANGING THE ADDRESSES OF SEVERAL LOCATIONS FROM PINE STREET TO IMMACULATE CONCEPTION DRIVE AND DESIGNATING WHEN THIS ORDINANCE SHALL TAKE EFFECT.**

**WHEREAS**, the City of St. Mary, Missouri recognizes that a section of Fourth Street has been given Pine Street addresses, and

**WHEREAS**, emergency responders are confused by this addressing, and

**WHEREAS**, renaming this section of street to Immaculate Conception Drive would alleviate this problem,

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. MARY, MISSOURI, AS FOLLOWS:**

**SECTION 1.** The Board of Aldermen hereby change that section of Fourth (4th) Street between Pine Street and Walnut to Immaculate Conception Drive. This will also include the drive from Pine Street to this section of Fourth Street that runs parallel with the Immaculate Conception Church and Church rectory.

**SECTION 2.** The following locations will be changed from Pine Street Addresses to Immaculate Conception Drive:

Immaculate Conception Rectory--483 Immaculate Conception Drive  
Immaculate Conception Church Hall--487 Immaculate Conception Drive  
Immaculate Conception Church--489 Immaculate Conception Drive  
Immaculate Conception Utility Shed--485 Immaculate Conception Drive  
Kathy Aubuchon---497 Immaculate Conception Drive  
Don Camp--499 Immaculate Conception Drive

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and approval.
