**ORDINANCE NO. 802**

**AN ORDINANCE AMENDING ORDINANCE NO. 613 PERTAINING TO ANIMALS IN THE CITY LIMITS, ON CITY OWNED PROPERTY AND IN THE CITY CEMETERY AND DESIGNATING WHEN THIS ORDINANCE SHALL TAKE EFFECT.**

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. MARY, MISSOURI, AS FOLLOWS:

SECTION 1. This ordinance shall delete Section 6 and Section 10 of Ordinance No. 613 in their entirety and enact the following new Sections 6 and Section 10.

**SECTION 6. Livestock running at large prohibited, nuisance declared, impoundment.**

It shall be unlawful for any person, persons, firm or corporation to keep or house any type of livestock, within the corporate limits of the City of St. Mary, Missouri. It shall be unlawful for any owner of any livestock animal to permit any such animal to run at large within the city limits or on any city owned property including the city cemetery. Any such animal running at large shall be declared a nuisance. It is the duty of the city police or animal control officer to at once to take up any animal found running at large in violation of this section and impound it in some safe place until same shall be disposed of according to section 8. Any violations shall be subject to a fine of not less than \$25.00 (Twenty-five Dollars) and not more than \$100.00 (One Hundred Dollars).

**SECTION 10. Dogs and cats running at large prohibited.**

It is unlawful for any person having the care or control of a dog or cat to allow such dog or cat to run a large within the city limits, on any city owned property including the city cemetery. No dog shall be allowed to roan upon the streets or sidewalks of the city, city owned property or city cemetery unless the dog is securely fastened to a leash and the leash held by some person at all times. Failure to comply shall be subject to a fine or not more than \$25.00 (Twenty-five Dollars) but not less than \$10.00 (Ten Dollars)


SECTION 2. Ordinances or parts of ordinances in conflict are hereby repealed.


