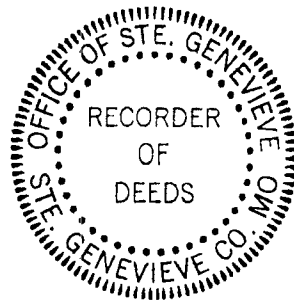

ORDINANCE NO. 909

WHEREAS: The Board of Aldermen have determined that the City of St. Mary has no plans for the further development of that portion of Locust Street; and

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF SAINT MARY, MISSOURI, AS FOLLOWS:

SECTION ONE: The City of Saint Mary hereby vacates a portion of Locust Street, East of Highway 61 between Block 16 Lot 1 and Block 9 Lot 18.

SECTION TWO: The City of Saint Mary hereby retains an easement on a portion of Locust Street, East of Highway 61 between Block 16 Lot 1 and Block 9 Lot 18.

SECTION THREE: In compliance with applicable Missouri Statutes, the vacated portion of Locust Street shall revert to the original owners of the adjacent in the proportion as it was taken from them.

SECTION FOUR: This Ordinance shall be in full force and effect from and after its passage.

SECTION FIVE: All Ordinances and parts thereof in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION SIX: The invalidity of any section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts.


